AUTHORIZATION LETTER & DECLARATION OF AGENCY FOR ONLINE INTELLECTUAL PROPERTY ENFORCEMENT

- Identify, investigate, and report impersonation, unauthorized brand or identity use, and other violations connected to the Protected Content.
- Take any further lawful action, including coordination with law enforcement agencies, reasonably necessary to enforce the rights described in this letter.

4. Defamatory, Harassing & Misleading Use

Authorization under this letter extends to any use of the Protected Content that defames, harasses, threatens, or creates a false or misleading impression about the Rights Holder — including content that repurposes, recaptions, or recontextualizes material the Rights Holder has themselves publicly posted. 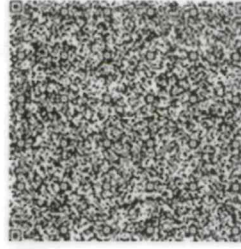
